Notes of a meeting of Mickleton Parish Council, held on Monday 21 July 2025 at 19:00 in Mickleton Village Hall.

25.99 APOLOGIES: None

25.100 DECLARATION OF INTEREST: Mrs R Fowler made a Declaration of Interest regarding the planning application for Cobblergate Lane.

25.101 MINUTES OF THE MEETING HELD ON 16 JUNE 2025 – These had been circulated, taken as read, agreed as a true record and signed.

25.102 TO CONSIDER ANY MATTERS ARISING FROM THE MINUTES NOT INCLUDED ON THE AGENDA – None

25.103 PUBLIC PARTICIPATION – Mrs Stewart outlined her concerns regarding the housing development on Cobblergate Lane and the effect the development was having on residents of Garth Cottages. To supplement her concerns, photographs were provided to detail her concerns, Mrs Stewart asked for the Parish Council's support to opposed the current VOC application and gave permission for the Parish Council to forward the photographs to DCC.

25.104 PLANNING MATERS

DM/25/0967/FPA – Erection of an agricultural building - awaiting the planning decision.

DM/25/0555/FPA - Grassholme Plantation – awaiting the planning decision.

DM/25/01318/PN56 – Land south of Carlton House – planning application has been withdrawn DM/25/01715/PNA – Prior notification for the construction of a forestry road – this is an additional planning application that has been submitted for the the new forest road – no concerns raised regarding the proposed road. It was noted that an osprey had been seen flying over the reservoir and woodland plantation. D Shepherd to make enquiries as to who to notify of this osprey siting. DM/25/01724/VOC – Land at Cobblergate Lane, - variation of Condition 2 pursuant to planning permission DM/22/03357?FPA (erection of 3no detached dwellings) to allow design changes and loss of garaging to Unit 1.

It was agreed to object to this VOC on the grounds of the impact that this would have on the residents of Garth Cottages owing to the height and levels of the development overshadowing the Cottages. From the photographs provided was there room for 2 parked vehicles, as shown on the documents. It was also agreed to ask the Planning Officer to make a site visit to check the non compliance issues brought to the Parish Council's attention regarding the upstairs windows of Plot no.2. It was also agreed to forward the photographs provided by Mrs Stewart onto the DCC Planning Officer

To be discussed in more detail at our September meeting. D Shepherd agreed to contact DCC regarding attaching lights to the street light poles.
