Setting of the 2026/27 Precept

The Clerk had circulated the draft budget information.

The proposed budget figures totalled £10,192.00

Clerk reported that the current laptop was obsolete and to meet the current standards needed to comply to procedures, a new laptop was required. It was agreed to include a figure of £600 towards a new laptop.

It was also agreed to include a figure of £2000 towards the purchase of speed awareness signs.

Total proposed expenditure = £12792.00

After discussion it was agreed to raise the precept to £80 per Band D property, giving a precept request for £15832.00. Proposed by D Hancock, seconded by J Lonsdale and agreed by all Council members.

CHRISTMAS LIGHTS/SWIFT BOXES

A number of Councillors and helpers had installed the Christmas Lights on various poles through out the village. The lights purchased for the village hall trees had also been installed and a Christmas Tree had been donated and installed in the Community Garden.
